

### Terms of agreement

### 1. The Validity of the Registration and the Enrollment Fee

All enrollments (oral or done by e-mail or on enrollment form) to Gymi Classes, courses, parties, events and camps are always valid and binding.

The enrollment fee is determined by the chosen GymiClass and the starting point during the term. The pricelists can be found on each Gymi's internet site. The customer may and should confirm the final price before enrollment.

If the customer chooses to pay by bill, an extra 5 € billing fee will be added to the enrollment fee.

If the customer has done the enrollment to a trial class, is he/she obligated to pay the fee for trial class indicated in the pricelist. The enrollment to a trial class does not guarantee the customer a place in the specific group for the rest of the term. If the customer wants to confirm his/her place for the whole term, he/she should make the binding enrollment for the term.

# 2. Participation in Class

The child's guardian has the obligation to see to that the child has appropriate attire when attending class. This means for example a T-shirt and shorts and a bottle of water. You may NOT bring a sick child to class.

The children and adults attending Gymi Classes are obligated to follow the Gymi Rules and the guidelines given by the Gymi Instructor.

# 3. Absence

Being absent from class due to illness or travelling does not entitle You to any lowering of the enrollment fee. If the child quits in the middle of the term, no fee will be compensated. The guardian is obligated to pay also for the non-attended classes on grounds of this agreement.

The lost class can be compensated by another class during the on-going term. The compensation must always be agreed upon beforehand with Gymi.

In some cases of illness or injury, the lost classes can be compensated during the following term. An agreement of this kind of compensation is always made case by case, and the customer must present a medical certificate of the illness or injury causing a total prohibition of at least one month.

### 4. Contents of the Activity

In GymiClass different kinds of skills are trained, sporting as well as social skills. More specific details of classes can be found in internet (<a href="www.gymi.fi">www.gymi.fi</a>) or in the brochure.

### 5. Gymi's Responsibility

Gymi is responsible for functioning properly and according to this agreement. Gymi functions according to its values respecting the children and adults at Gymi and taking into account all the children equally. According to Gymi Values, Gymi provides health (physical as well as mental health) enhancing services.

Gymi is responsible for the proper state of the equipment in the hall.

Gymi has NO insurance for injury or accident for the children and adults participating in Gymi Activities.

Gymi is not responsible for any damage done to clothes, toys or other possessions of people participating in Gymi Activities. Neither is Gymi responsible for possible disappearing of possessions.

### 6. Responsibilities of the Guardian

The guardian is responsible for the safe being of his/her child/children during guardian-child classes. During guardian-child classes, the guardian is obligated to participate in the class activities with his/her child.

The child's guardian has the obligation to see to that the child has appropriate attire when attending class. In Gymi Activities, it is only allowed to attend in clean sporty attire.

The child's guardian is responsible for bringing his/her child on time to Gymi Class (max 10 minutes before class start) and for being on time to fetch his/her child when the class is finished. You may NOT leave Your child alone before the class has started. Gymi has no responsibility of a child left alone in Gymi area before class start. Gymi's responsibility for the child ends when class ends. The guardian is obligated to fetch his/her child at this given point if not otherwise agreed. Gymi is not responsible for the child on the way to or from Gymi.

#### 7. Terms of Cancellation

Possible cancellations are always to be made in writing and with a possible medical certificate attached. If the cancellation is done later than 30 days before the beginning of the activity, 50% of the course fee will be charged. In case of no cancellation notification or in case the cancellation is done later than 7 days before the beginning of the activity, the whole course fee will be collected. The amount of participants in a private activity (for example a

birthday party) must be confirmed no later than 3 days before the event. Billing is done according to this confirmed number or in case there are for some reason more participants in the event, according to the amount partipants attending.

The organizer may cancel a class, course, camp or other activity in case there are not enough participants.
